- 1. Minutes of the 2/17/81 meeting read and accepted.
- 2. Treasurer's Report \$398.00 in checking account accepted
- 3. The 2nd Edition of the News Letter was passed out for distribution.
- 4. The benefit at Rustlers was mentioned scheduled for March 16 at 9:30 PM
- 5. Barry Ford was nominated as the Vice Commissiomer of the League.

Motion - Barry Ford is the Vice Commissioner of the Beantown Softball League for the remainder of the 1981 Season.

- 6. Vic announced that all the raffle prizes from the Elbow Room's League benefit have been passed out.
- 7. Joe Leo presented information on the line of sporting goods which he has available.

- 9. It was noted that sponsors need to be aware that the #250.00 sponsor fee is due by the April 2nd meeting.
- 10. There is no further word on the field permits. Vic is contnuing to keep in touch with the Park Department. The hang up continues to be a lack of a decision on how much the City will be charging for field permits and lights.
- 11. The idea of advertising for prospective players in papers other than the "bar papers" was mentioned.
- 12. The upcomming NAGA meeting was discussed. Gary Staples and Vic Santilli will be sent as our League representitives. Gary will be there for the duration of the meetings (Thurs. through Sun.), Vic will be going up Friday night.
- 13. There was discussion about sending a letter of support to the Toronto gay community concerning the recent serious problems between the community and the police/government. Seth Hyde will present a draft letter at the next meeting.
- 14. Rule books will be distributed at the next meeting. We will have a rules decision meeting about two weeks after the next Executive Committee meeting.

- 15. Vic outlined projected costs of the League based on the number of teams. Six, seven and eight team operations were discussed. It is apparent that if we go to an eight team league we will have to break it into two divisions (probably evenly matched) with teams playing other teams in their division three times and teams outside their division twice.
- 16. A suggestion was voiced that Phil (foremerly of the 1270 team) be asked to throw out the first ball of the season.
- 17. Vic presented some receipts for which he needed reimbursement.
 They included phone calls to Toronto, costs of printing the
 news letter (Copy Cop)
 - Motion To reimburse Vic Santilli \$49.49 for out of pocket expenses including phone bills and printing of the League newsletters.

- 1. Minutes of the 3/12/81 Meeting read and accepted
- 2. Treasurer reported \$458 raised from the Elbow Room benefit, 644 raised from the Rustlers benefit. \$400 paid by Isaiahs for league entry fee and partial payment of individual member fees (which are not due until May/June). Treasurer also noted disbursement for stationery, air fare to Toronto NAGAAA conference. Current checking balance \$1228.82.

1270, Paradise and Chaps presented their \$250 League entry fee checks to be deposited. Treasurer's report was accepted.

- 3. Bill MacKay requested reimbursement for the cost of the League mailbox (1 yr) and a rubber address stamp for League business. The Committee voted to reimburse the Secretary for \$37.98 (PO Box \$28.00, Rubber Stamp \$9.98)
- 4. UPCOMING BENEFITS Vic announced that the next two League benefits will be at Buddies (Wed. April 8) and Paradise (Tues., April 28). Seth Hyde explained how the Buddies benefit will work. \$2 admission will be charged at the door with \$1 going to the League. A free drink will be given with each admission (the cost of the drink being absorbed by Buddies). There will also be raffles, ** *uth*ones**andfth**Leinga**b**Loop**b**Ebuddies
 - 5. RULES Vic passed out the rule books to team reps. and officers. There will be a meeting on Thursday, April 16 at 7:30 to set the rules for this year.

7. FIELD PERMITS - Vic reported on his latest conversation with the Park Dept.-Permits still have not been issued. It looks like the fees charged will be as follows - A \$50 filing fee for permits. \$10 per game for field maintenance. \$25 per hour for lights.

There was a good deal of discussion of the fees, of the possibility of playing no games under the lights (ie. just one game Wed. nights) etc. - The consensus was that we need to play two Wednesday night games and that we'll just have to raise the necessary money to pay for Saturdays, Sundays and Wednesdays.

Vic also reported that the Park Dept. told him our request for permits was the 11th. in line in the City and the 1st. in line for Clemente Field.

8. PRACTICE TIMES - Seth Hyde raised the issue of dividing up practice times on Clemente Field. It was noted that we do not yet have field permits and thus have no more right than anyone else to use the field.

Sundays, 2:00 to 4:00 - Herbies Sundays, 4:00 to 6:00 - Paradise

Note: Isaiahs will be practicing on their own field for the time being.

- 9. NAGA MEETING Gary and Vic reported the following relative to the Toronto NAGA meeting:
 - a) NAGA has changed its name to NAGAAA (North American Gay Amateur Athletic Assoc.)
 - b) Atlanta's league was admitted into NAGAAA
 - c) We must send the organization a map of our area and our constitution
 - d) It was voted to allow us to add Worcester to our area. It was also noted that should Worcester decide, at a later time, to join with Springfield in a Western Mass. league, that will be allowed, provided our league agrees to it.
 - e) NAGAAA has a problem with verifying last year's payments from the leagues, and is asking us for documentation that we paid
 - f) League rosters and playoff schedules are supposed to be to NAGAAA by June 1. There is, however, a one month grace period.
 - g) There will be no allowance for "injured reserve players" in this year's world series. We can send a team of no more than 18 players. With our 15 man roster, we will thus be allowed to add only three players from other teams.
 - h) Adds for the world series program were discussed. Consensus of our Committee is that we should buy an add.
 - i) Identification (W picture) must be presented by all players in world series. There apparently were some problems last year.
 - j) NAGAAA dues this year are \$325
 - k) No player can be on rosters of teams in more than one NAGAAA associated league

10. NEW TEAMS - Reps from Randolph Country Club and Prelude presented requests to enter teams in the League. There was much discussion and questioning around how well the teams were organized, their finances, their commitment etc.

That, upon payment of the League entry fee, Randolph Country club's team be added to the 1981 Beantown Softball League.

More discussion followed about Prelude's financial situation (They are trying to raise money for the League entry fee) and about the fact that several of last year's teams have yet to pay their League entry fee (Sponsor fee) which was due on April 1.

No conclusion was reached as to which team will go.
- 12. LETTER OF COMPLAINT The Secretary read a letter addressed to the Commissioner which stated a former League member's displeasure about our adoption of the 80/20 rule and mentioned how the straight ball players in the League allegedly took away places of gays who would like to be playing. There was considerable (and somewhat heated discussion) of the points raisead and the appropriateness of reading the letter. The arguement was a draw.
