Rick Harrington For Assistant Commissioner

Dear BSL Member:

John Haas for Assistant Commissioner

My name is John Haas and I am running for the office of Assistant Commissioner of the Beantown Softball League for the 1992-93 season. After hearing concerns that many of you expressed about last year's season, I feel that my prior experience as League Secretary, and in my professional field could benefit our league, should I be elected.

The primary responsibility of the Assistant Commissioner, is to see that all on field activities run smoothly, and safely. This includes the development of a proposed league schedule, which is then approved by the Executive Committee, and making sure that the field are groomed

before each day's play.

I think that it is important that each league member be notified of the play schedule as early as possible before opening day. To this end, I would ask the commissioner to appoint at least one person from each of the past years divisions to aid me in developing a schedule. This would give the Executive Committee a base upon which to approve a final schedule that more truly represents the needs and wants of the league. Through the use of a computer scheduling package, I would be able to change the schedule at the actual league meeting, giving out copies immediately so that the executive committee could take them with them, review them with their teams, and be prepared at the subsequent meeting to make any needed adjustments there-by approving the schedule at least two weeks sooner than usual.

We are out-growing Daisey Field. We need a facility that has open outfields. I will meet with the Parks and Recreation Department to see if we can get an alternative

playing site.

I would ask the Executive Committee to approve a plan whereby each team would be responsible to help me groom the fields for one weekend during the season. This would insure that each of you had the best and safest pos-

sible conditions under which to play ball.

Finally I think it may be time to reappraise the three division format we have been playing under. A two division format with a prior positional round would make each of the divisions more fairly proportioned. This format would also avoid penalizing a team that places in an upper division with marginal stats. The Executive Committee would decide how many teams would be in each division.

I hope that you will be able to vote for me at the September 13th general meeting and banquet. Congratulations on another great season in the B.S.L. Thank you.

Now that the softball season has ended, it is time for you, as a voting member of the BSL, to stop and think, where you want the league to go. Is it okay as is or is it time for a change?

With the dissatisfaction felt throughout the league this year, I believe it is time for a change and I would like to be

a part of that change.

So, at this time I would like to ask you for your support in my campaign for Assistant Commissioner. I will now outline for you, the responsibilities of the Assistant Commissioner and enlighten you on ideas I have that will change the league.

To begin, the responsibilities, as outlined in our Con-

stitution, under Article II, Section II states:

The Assistant Commissioner shall: (1) Assume the duties of the commissioner in the event of the commissioner's resignation, impeachment, or other absence or disability. (2) Be a voting member of the Executive Committee. (3) Be a chairperson of the Special Events Committee.

Included, in our By-Laws, under Section II Executive Committee, C. Officers: 2. Assistant Commissioner.

Is responsible for: (a) Obtaining field and light permits.
(b) Field maintenance. (c) Opening day ceremonies. (d) End of the year banquet. (e) Drafting a potential league schedule for Executive Committee approval.

My past and present work experience have included administrative and managerial positions along with my affiliation with the Minuteman Classic Committee as the Assistant Chairman qualifies me for such an electable office.

As for my ideas, my main concern is to see the league unite through better communication and make it more friendly, like it was intended for at the time of its creation. To try and eliminate the political escalations, after all, we are only a softball league and not an independent government.

All this can be accomplished if we would consider changing from the A-B-C format back to the two division format (A&B) that we used two years ago. Based on 14 teams, we will have 6 teams in the A division with the respective 8 teams in the B division. This would be accomplished by a positional round, all included, at the start of regular season.

I also have an idea that would keep every team, regardless of their record, involved through the last weekend of play. That is to send the winner of the A division, regular season, to the World Series as the A representative. We will hold a random draw, comprised of those teams positioned in the B division after the positional round, to determine who goes to the Worlds Series as the C division representative. The remaining teams in both divisions will play a double elimination tournament over one weekend and the winner will be the B division representative in the Worlds Series.

In addition, the scheduling of the league buffets and fundraisers proved to be disastrous. I would suggest that

league buffets and team fundraisers be assigned. To explain, during preseason we will hold a random draw to determine who will hold the buffets and on what weekend. In retrospect, we will do the same for fundraisers. Each team will be given an assigned week to hold their respective fundraisers.

Hence, I have no control over whether or not these ideas will be initiated, but I will work closely with the newly elected commissioner to see that what can be done is done. Also, if any league member has any ideas or concerns regarding the league confront me with either and I will see that all are considered and answered.

Alas, I am determined, if elected, to work for you, the General Committee, to see that what the committee wants the committee gets. After all, it is your league and you are who I work for. I shall close for now and may the best and most qualified candidate be elected. Thanks for your support.

Four officers is too much for any one sponsor--and eight votes should be out of the question. Likewise, four terms is too much, it's good to shake things up now and then—I said that in 1988 when I could have run again and I say it now.
